As we approach the final days of the year, we'd like to remind you that this is an excellent time to review your year-end tax-saving opportunities. Canada's tax rules are particularly favorable for charitable giving, offering a **refund of up to 46%** for eligible donations.

To better understand how these benefits apply to your income bracket, please read this article. You'll also find insights into additional ways to give, such as donating corporate shares (avoiding personal tax on the capital gains, while claiming the deduction), naming a charity in an insurance policy, and more.

Below is an example of the potential tax benefits of charitable giving. Please note that this is for illustration purposes only, and your individual situation may vary based on your income and other deductions.
